ACCEPTABLE USE POLICY and PARTICIPATION AGREEMENT

Highland Reserve State School believe in developing key skills of the 21st Century Learners, including creative and critical thinking, effective communication and collaboration. Through our iLearn@HRSS program, students in Years 2 and 4, 2018 will have access to their own personal iPad, which will enable opportunities to engage with the curriculum and educational materials, anywhere and anytime. Consistent with our School Rules, it is expected that students will **be a learner, be safe, be respectful and be responsible** when using their own iPad at school.

Parents and Students, please carefully read the **Acceptable Use Policy** and **Participation Agreement** and return the form to the school office. This form must be completed and returned prior to student participation in our iLearn@HRSS program. **PLEASE ENSURE THE BLUE FORM IS RETURNED BY FRIDAY 3rd NOVEMBER**

Student Responsibilities:

- Ensure that the iPad is charged at home and brought to school each school day
- Ensure that the iPad is taken home each afternoon
- Ensure that the iPad is carried in a bag to and from school
- Ensure that the iPad always has the protective case on it
- Report any accidental damages to teachers and families
- Leave the iPad charger at home, unless under special circumstances and directed by families
- Ensure that the iPad, apps and websites are only used to support classroom learning and classroom content
- Ensure the iPad remains in locked classroom at lunchbreaks, unless supported by a teacher in a small group situation
- Ensure that there is **NO PASSCODE** on the iPad
- Only connect to Education Queensland's MIS (NO 3G whilst at school)
- Ensure that I follow the school's ICT rules - Be a learner, Be Safe, Be Respectful and Be Responsible when using ICTs
- Report if someone has breached the school's ICT rules
- Understand consequences for not adhering to school's ICT rules

Parent Responsibilities

- Purchase the iPad, as per device specifications

- Provide cyber safety education for your child
- Provide web filtering when at home

- Ensure Year Level Required apps are loaded onto the iPad, ready for term 1 (emailed end of Term 4, 2017)
